PUBLIC NOTICE OF

The City of Henderson is presenting a Consolidated Annual and Performance Report (CAPER) to the U.S. Department of Housing and Urban Development. The information in this report summarizes the activities “expended” of the City's 2020 Community Development Block Grant Program. A copy of this report will be available for public review and comment on Monday, September 13, 2021 between the hours of 9:00 a.m. and 4:00 p.m., until Tuesday, September 28, 2021 at the City of Henderson Peabody Safety Building, office of the Community Development Department, 1990 Barret Court, Suite B; the Henderson County Public Library, 101 South Main Street and the City of Henderson Community Development designated web page for review at www.cityofhendersonky.org. Due to the on-going COVID-19 pandemic, all local regulations and protocols must be followed regarding face masks, social distancing, temperature scanning when entering City of Henderson Peabody Safety Building and John F. Kennedy Center for review of the Plan.

The City will hold several public hearings at different times to allow citizens to review and comment on the Consolidated Plan and Annual Performance Report. Public hearings will be on **Wednesday, September 22 at 10:00 a.m. and 6:00 p.m. (John F. Kennedy Community Center Conference Room)**, 515 South Alvasia Street, Henderson, Kentucky and **Thursday, September 23 at 10:00 a.m and 6:00 p.m.** at the City of Henderson **Peabody Safety Building (Codes/Community Development Meeting Room)**, 1990 Barret Court, Suite B, Henderson, Kentucky. All interested citizens are encouraged to attend and must follow all COVID-19 requirements when entering the premises.

The meeting rooms at the City of Henderson Peabody Safety Building and John F. Kennedy Community Center are accessible to the disabled.
